PREFACE

Minnesota law enforcement agencies provide information about criminal activity including incidents, stolen and recovered property and arrests to the Minnesota Bureau of Criminal Apprehension (BCA) to meet state and federal reporting requirements. The BCA's Uniform Crime Reporting Program compiles the data, which also includes information about law enforcement officers killed and assaulted; firearms discharges by police officers; police pursuits and bias offenses. Limited information is also available on law enforcement personnel.

Minnesota Crime Data Explorer

In years' past, the compiled data was published in the Uniform Crime Report. However, the BCA launched a new public database in 2021 called the Minnesota Crime Data Explorer, a modernized tool from which current crime data can be obtained at any time. Links to the database appear throughout this report.

The Minnesota Crime Data Explorer also contains much more detailed information than had been available in the past because of the concurrent transition by Minnesota law enforcement agencies to a much more detailed approach to crime reporting using the National Incident-Based Reporting System (NIBRS). While past reporting contained summary data about the most serious offense associated with an incident, incident-based reporting includes many more details on all crimes associated with an incident, as well as detailed data about victims and offenders and much more.

Together, the Minnesota Crime Data Explorer and the National Incident-Based Reporting System have led to greater transparency and detail available about incidents that occur in Minnesota communities. This enables criminal justice entities, researchers and the public to better understand, respond to and prevent incidents in their communities.

History of Crime Reporting in Minnesota

In 1935, the Minnesota Legislature mandated that the BCA make available to interested parties crime data received from Minnesota law enforcement agencies. Uniform Crime Reports containing this information were compiled and provided every two years as required by state statute until 1972, when the reports began to be produced annually.

With the introduction of the Minnesota Crime Data Explorer, the BCA meets this mandate in near real time. This document serves as a summary of the 2023 information contained in the Minnesota Crime Data Explorer as of May 20, 2024.

The BCA wishes to thank the cooperating law enforcement agencies whose assistance make the Minnesota Crime Data Explorer and this report possible. Each agency is responsible for the accuracy, completeness and timeliness of the data the agency chooses to submit. Agency policy on what to submit may vary and those variances are reflected in the data. In addition, because the types of crimes and level of detail about those crimes have changed in recent years any comparisons with previous years should be viewed with caution.

CRIME DATA COLLECTION

Legal Requirements to Report Crime Data

The state of Minnesota has participated in the FBI's Uniform Crime Reporting (UCR) Program since 1936. Minnesota statutes require and authorize the BCA to collect UCR data. The state statutes authorizing data collection are as follows:

OFFENSE OVERVIEW

Offense Overview

The following is an overview of 2023 crime data including Group A offenses and Group B arrests.

The data includes Index Crime Volume and Change. This is data on eight major offenses (criminal homicide, rape, robbery, aggravated assault, burglary, larceny, motor vehicle theft and arson) that the FBI uses to evaluate changes and trends.

An offense is considered cleared when at least one person involved in the commission of the offenses has been (1) arrested, (2) charged, and (3) turned over to the court for prosecution.

An incident is cleared by exceptional means if some element beyond law enforcement control prevents filing of formal charges against the offender. Agencies can clear an offense exceptionally if they can answer all of the following in the affirmative.

- Has the investigation definitively established the identity of the offender?
- Is there enough information to support an arrest, charge, and turning over to the court for prosecution?
- Is the exact location of the offender known so that the subject could be taken into custody now?
- Is there some reason outside law enforcement control that precludes arresting, charging, and prosecuting the offender (examples include suicide, deathbed confessions, double murder, etc.)?



INDEX CRIMES

Violent Crime Overview

Violent crime in Minnesota accounted for 6.4 percent of all offenses reported in 2023. There were 15,011 total violent crimes for the year. Compared with the 16,119 total violent crimes reported for 2022, the 2023 figure represents a decrease of 6.9 percent in violent crime for the state. The number of violent crimes for the state was 261.3 per 100,000 population.

- **Murder** — Offenses involving murder totaled 181 in 2023 compared to 182 in 2022, a decrease of 0.54 percent.
- **Rape** — There were 2,053 rapes reported in 2023 and 2,329 in 2022, a decrease of 11.85 percent.
- **Robbery** — There were 2,791 robberies reported in 2023 and 3,266 in 2022, a decrease of 14.54 percent.
- **Aggravated Assault** — Offenses involving aggravated assault totaled 9,986 in 2023 compared to 10,342 in 2022, a decrease of 3.44 percent.

Violent crime data is provided below by statewide totals, the seven-county Twin Cities metro area, and all counties excluding the Twin Cities metro area.

INDEX CRIMES

Property Crime Overview

Property crime in Minnesota in 2023 amounted to 42.3 percent of all offenses reported. There were a total of 99,355 property crimes reported in 2023. Compared with the 114,345 offenses reported in 2022, the 2023 figure represents a decrease of 13.1 percent in property crime for the state. The number of property crimes for the state per 100,000 population for 2023 was 1,729 and in 2022 it was 2,000.

- Burglary — There were 10,416 burglaries reported in 2023 and 12,144 in 2022, a decrease of 14.22 percent.
- Larceny/Theft — There were 72,701 larcenies reported in 2023 and 84,830 in 2022, a decrease of 14.29 percent.
- Motor Vehicle Theft — There were 15,612 motor vehicle thefts reported in 2023, a decrease of 6.75 percent.
- Arson — There were 626 arsons reported in 2023 and 628 in 2022, a decrease of 0.31 percent.

Typically, auto theft occurs when the owner of the vehicle is not around and the vehicle itself is unoccupied.

A carjacking is when the vehicle is taken by force (robbery) while the driver or passengers are entering or within the vehicle.

CRIMES OF VIOLENCE – HOMICIDE

Criminal Homicide – Murder

Criminal homicide involves those offenses of murder and non-negligent homicide that are classified as willful felonious deaths as distinguished from deaths caused by negligence. “Attempts to kill” are reported as aggravated assaults and not as murder. Justifiable or excusable homicides, suicides, accidental deaths, and deaths due to negligence are not tabulated in the state criminal homicide total.


Summary Homicide Information

In 2023, there were 188 homicides reported for the state; 7 were ruled justifiable, yielding a total of 181 criminal homicide victims. 147 criminal homicides were cleared by arrests or exceptional means in 2023, with 14 of these arrests of a juvenile only. There were 61 negligent homicides reported for the year. The crime rate for criminal homicide in 2023 was 3 per 100,000 population.

Data on homicide of an unborn victim is collected to meet Minnesota reporting requirements. It does not meet the FBI’s Uniform Crime Reporting definition of homicide. As a result, homicide of an unborn is reported as a separate category. There were 0 homicides of an unborn in 2023.



Victim Offender Relationship



Type Weapon or Force Involved






Homicide Victims by Age




Homicide Offenders by Age




Homicide Victims by Sex




Homicide Offenders by Sex

CRIMES OF VIOLENCE – RAPE

Rape

This includes any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent.

The FBI Uniform Crime Reporting definition for rape includes “the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.” For this section, it includes the following offenses:

- Rape (except incest and statutory rape) — the carnal knowledge of a person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.
- Sodomy — oral or anal sexual intercourse with another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.
- Sexual assault with an object — to use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.

Summary Rape Information

In 2023, there were 2,054 offenses of rape reported, with 2,053 victims. Of the offenses reported, 2,031 were completed and 23 were attempted. 586 rapes were cleared by arrests or exceptional means in 2023, with 49 of these arrests of a juvenile only. The crime rate for rape in 2023 was 35.7 per 100,000 population.



Crime Category





Victim Offender Relationship



There were 372 carjacking incidents reported in 2023 and 598 in 2022, a decrease of 37.8 percent. Of the 372 carjacking incidents reported in 2023, 109 were cleared by arrest or exceptional means with 39 of these by the arrest of a juvenile only. The crime rate for carjacking in 2023 was 6.5 per 100,000 population.




Carjacking Offenders by Age



Carjacking Victims Injured vs. Uninjured




Carjacking Victim Injury Type

ARRESTS OVERVIEW

Firearms Discharges

Pursuant to Minnesota State Statute 626.553, Subdivision 2, information is collected concerning firearm discharges by law enforcement officers in Minnesota. 1978 was the first full year that this information was available.

Summary Firearms Discharge Information

There were 29 firearms discharge incidents in 2023, with 114 shots fired. Of these, 17 incidents were in the course of duty or employment and 12 were accidental discharges. There were 19 individuals fired at, of these:


- 7 were killed
- 5 were wounded
- 7 had a resulting injury level of 'other', meaning they were not injured as a result of the firearms discharge.

Two discharges were in the course of employment by private security. One accidental discharge resulted in a shot being fired in the general direction of an individual.


Incident Discharge Reason




Results of Shots Fired at Individuals

FIREARMS DISCHARGE AND USE-OF-FORCE

Use-of-Force

The Minnesota Legislature in 2020 enacted Minnesota State Statute 626.5534 which requires Minnesota law enforcement agencies to provide information about use-of-force for the FBI Use-of-Force Data Collection. Agencies had already begun providing data on a voluntary basis in 2018 shortly after the FBI first established the data collection. The FBI created this data collection to inform the national conversation about officer use-of-force and provide an aggregate view of reported incidents and their circumstances, subjects and officers involved for better statistical analysis.

The FBI identified three types of use-of-force incidents about which agencies must report:

- When a fatality occurs to a person in connection to use-of-force by a law enforcement officer.
- When there is serious bodily injury to a person in connection to use-of-force by a law enforcement officer.
- In the absence of either death or serious bodily injury, when a firearm is discharged by a law enforcement officer at or in a direction of a person.


The FBI requirements allow agencies to choose Pending or Unknown values for data elements when data is not known or cannot be released due to an outside agency's active investigation. Agencies are expected to amend the reports once the data becomes available. In the figures below, 'Subject' indicates the individual that the force was applied to.

Summary Use-of-Force Information

In 2023, there were 21 use-of-force incidents*. 7 of these incidents involved the death of a subject, 9 of these incidents involved the serious bodily injury of a subject, and 5 of these incidents did not involve the death or serious bodily injury of the subject.

* This number does not include 2 incidents in which an employee of a private security firm discharged their weapon.


LAW ENFORCEMENT EMPLOYEE INFORMATION

Minnesota state law enforcement agencies reported a total of 15,839 sworn and civilian employees for 2023. Of those, 9,969 were sworn personnel and 5,870 were civilian employees.

The average number of full time law enforcement personnel in 2023 (including sworn and civilian) amounted to 2.8 employees per 1,000 residents. The average number of sworn personnel (excluding civilian) amounted to 1.7 full-time sworn personnel per 1,000 residents.


Staffing levels in 2023 and changes from the previous year were as follows:

- Sheriff's departments reported a total of 6,340 employees in 2023, which was an increase of 3.8% from the 2022 total of 6,105. Of the sworn personnel, 2,421 are male and 286 female. Of civilian personnel, 1,825 are male and 1,808 are female.
- Police departments reported a total of 7,546 employees in 2023, which was an increase of 1.8% from the 2022 total of 7,407. Of the sworn personnel, 5,073 are male and 833 female. Of civilian personnel, 593 are male and 1,047 are female.
