Preface

Minnesota law enforcement agencies provide information about criminal activity including incidents, stolen and recovered property and arrests to the Minnesota Bureau of Criminal Apprehension (BCA) to meet state and federal reporting requirements. The BCA's Uniform Crime Reporting Program compiles the data, which also includes information about law enforcement officers killed and assaulted; firearms discharges by police officers; police pursuits; and bias offenses. Limited information is also available on law enforcement personnel.

Minnesota Crime Data Explorer

In years past, the compiled data was published in the Uniform Crime Report. However, the BCA launched a new public database in 2021 called the Minnesota Crime Data Explorer, a modernized tool from which current crime data can be obtained at any time. Links to the database appear throughout this report.

The Minnesota Crime Data Explorer also contains much more detailed information than had been available in the past because of the concurrent transition by Minnesota law enforcement agencies to a much more detailed approach to crime reporting using the National Incident-Based Reporting System (NIBRS). While past reporting contained summary data about the most serious offense associated with an incident, incident-based reporting includes many more details on all crimes associated with an incident, as well as detailed data about victims and offenders.

Together, the Minnesota Crime Data Explorer and the National Incident-Based Reporting System (NIBRS) have led to greater transparency and detail available about incidents that occur in Minnesota communities. This enables criminal justice entities, researchers and the public to better understand, respond to and prevent incidents in their communities.

History of crime reporting in Minnesota

In 1935, the Minnesota Legislature mandated that the BCA make available to interested parties crime data received from Minnesota law enforcement agencies. Uniform Crime Reports containing this information were compiled and provided every two years as required by state statute until 1972, when the reports began to be produced annually.

With the introduction of the Minnesota Crime Data Explorer, the BCA meets this mandate in near real time. This document serves as a summary of the 2025 information contained in the Minnesota Crime Data Explorer as of May 18, 2026.

The BCA wishes to thank the cooperating law enforcement agencies whose assistance make the Minnesota Crime Data Explorer and this report possible. Each agency is responsible for the accuracy, completeness and timeliness of the data the agency chooses to submit. Agency policy on what to submit may vary and those variances are reflected in the data. In addition, because the types of crimes and level of detail about those crimes have changed in recent years, any comparisons with previous years should be viewed with caution.

Crime data collection

Legal requirements to report crime data

The state of Minnesota has participated in the FBI's Uniform Crime Reporting (UCR) Program since 1936. Minnesota statutes require and authorize the BCA to collect UCR data. The state statutes authorizing data collection are as follows:

Offense overview

Offense overview

The following is an overview of 2025 crime data including Group A offenses and Group B arrests.

The data includes Index Crime Volume and Change. This is data on eight major offenses (criminal homicide, rape, robbery, aggravated assault, burglary, larceny, motor vehicle theft and arson) that the FBI uses to evaluate changes and trends.

An offense is considered cleared when at least one person involved in the commission of the offense has been arrested.

An incident is cleared by exceptional means if some element beyond law enforcement control prevents filing of formal charges against the offender. Agencies can clear an offense exceptionally if they can answer all of the following in the affirmative.

- Has the investigation definitively established the identity of the offender?
- Is there enough information to support an arrest, a charge and turning over to the court for prosecution?
- Is the exact location of the offender known so that the subject could be taken into custody now?
- Is there some reason outside law enforcement control that precludes arresting, charging and prosecuting the offender (examples include suicide, deathbed confessions and double murder)?

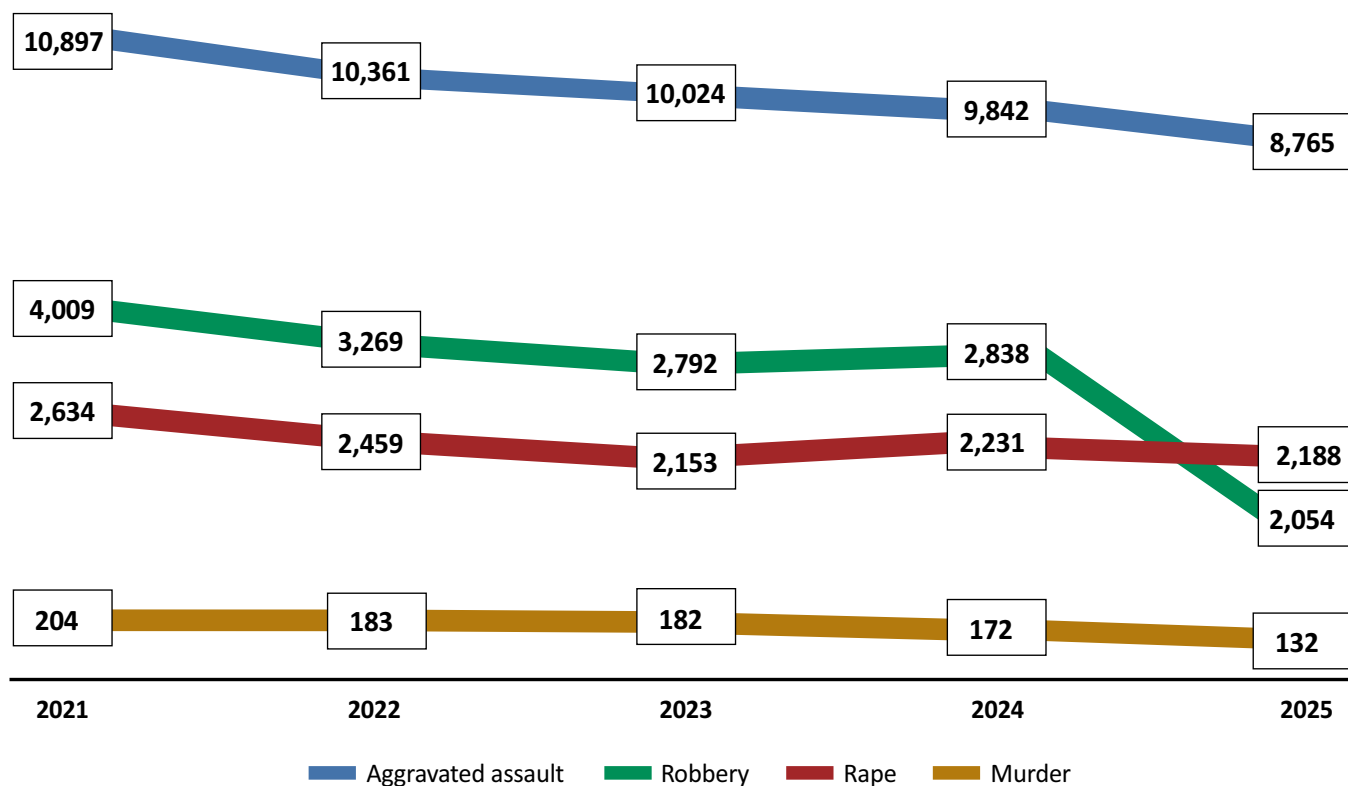

Index crimes

Violent crime overview

Violent crime in Minnesota accounted for 6.5 percent of all offenses reported in 2025. There were 13,139 total violent crimes for the year. Compared with the 15,083 total violent crimes reported for 2024, the 2025 figure represents a decrease of 12.9 percent in violent crime for the state. The number of violent crimes for the state was 225.3 per 100,000 population.

- Homicide: Offenses involving murder totaled 132 in 2025 in Minnesota compared with 172 in 2024, a decrease of 23.26 percent.
- Rape: There were 2,188 rapes reported in 2025 and 2,231 in 2024, a decrease of 1.93 percent.
- Robbery: There were 2,054 robberies reported in 2025 and 2,838 in 2024, a decrease of 27.63 percent.
- Aggravated assault: Offenses involving aggravated assault totaled 8,765 in 2025 in Minnesota compared with 9,842 in 2024, a decrease of 10.94 percent.

Index crimes

Property crime overview

Property crime in Minnesota in 2025 amounted to 41.3 percent of all offenses reported. There were a total of 83,754 property crimes reported in 2025. Compared with the 94,917 offenses reported in 2024, the 2025 figure represents a decrease of 11.76 percent in property crime for the state. The number of property crimes for the state per 100,000 population for 2025 was 1,436.5 and in 2024 it was 1,638.4.

- Burglary: There were 9,294 burglaries reported in 2025 and 10,618 in 2024, a decrease of 12.47 percent.
- Larceny/theft: There were 64,157 larcenies reported in 2025 and 71,075 in 2024, a decrease of 9.73 percent.
- Motor vehicle theft: There were 9,803 motor vehicle thefts reported in 2025 and 12,634 in 2024, a decrease of 22.41 percent.
- Arson: There were 500 arsons reported in 2025 and 590 in 2024, a decrease of 15.25 percent.

A carjacking is when the vehicle is taken by force (robbery) while the driver or passengers are entering or within the vehicle.

Criminal homicide – murder

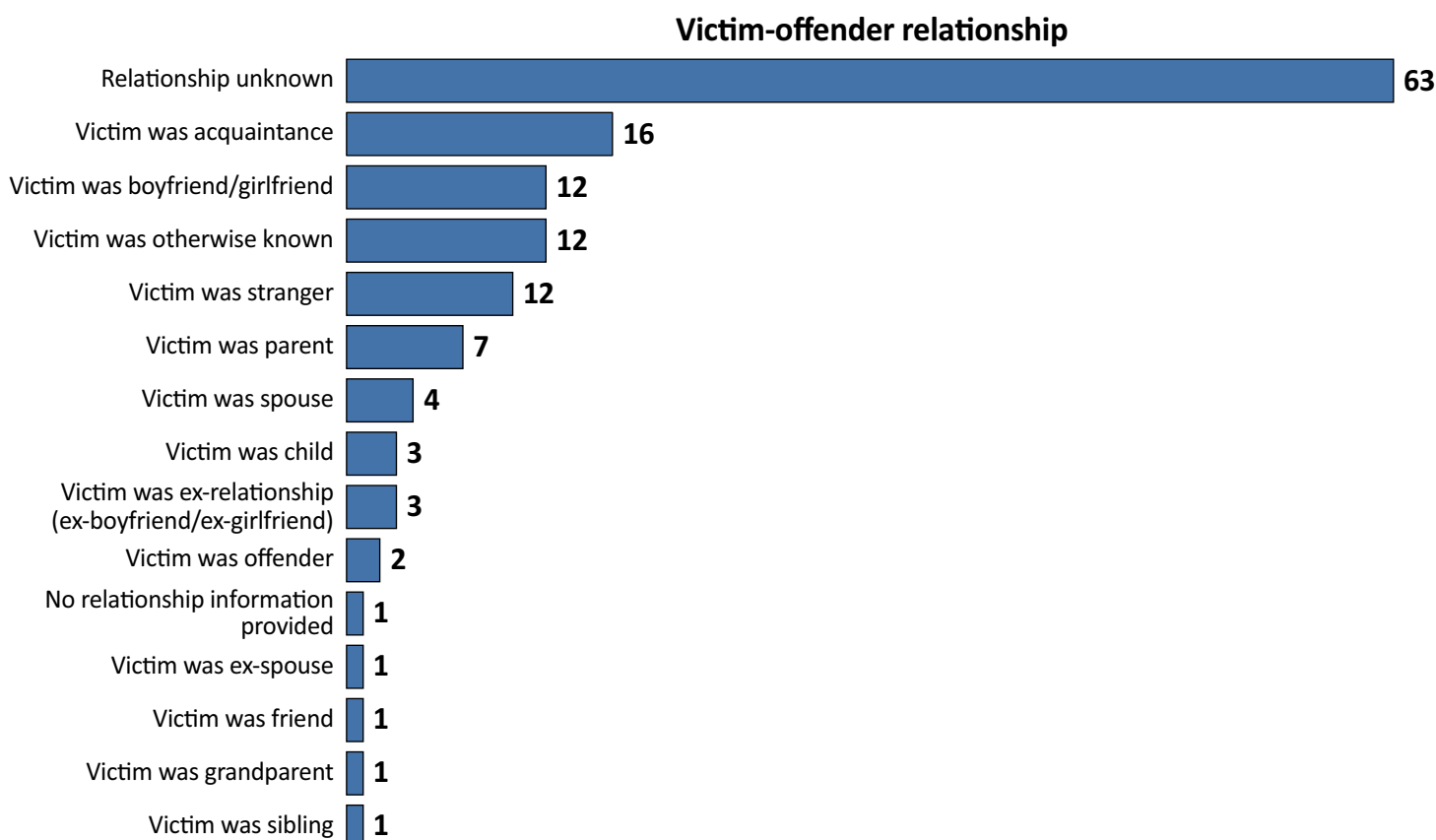
Criminal homicide involves those offenses of murder and non-negligent homicide that are classified as willful felonious deaths as distinguished from deaths caused by negligence. “Attempts to kill” are reported as aggravated assaults and not as murder. Justifiable or excusable homicides, suicides, accidental deaths and deaths due to negligence are not tabulated in the state criminal homicide total.

Summary of homicide information

In 2025, there were 141 homicides reported for the state; nine were ruled justifiable, yielding a total of 132 criminal homicide victims. In 2025, 103 criminal homicides were cleared by arrests or exceptional means in 2025, with 9 of these arrests of a juvenile only. There were 50 negligent homicides reported for the year. The crime rate for criminal homicide in 2025 was two per 100,000 population.

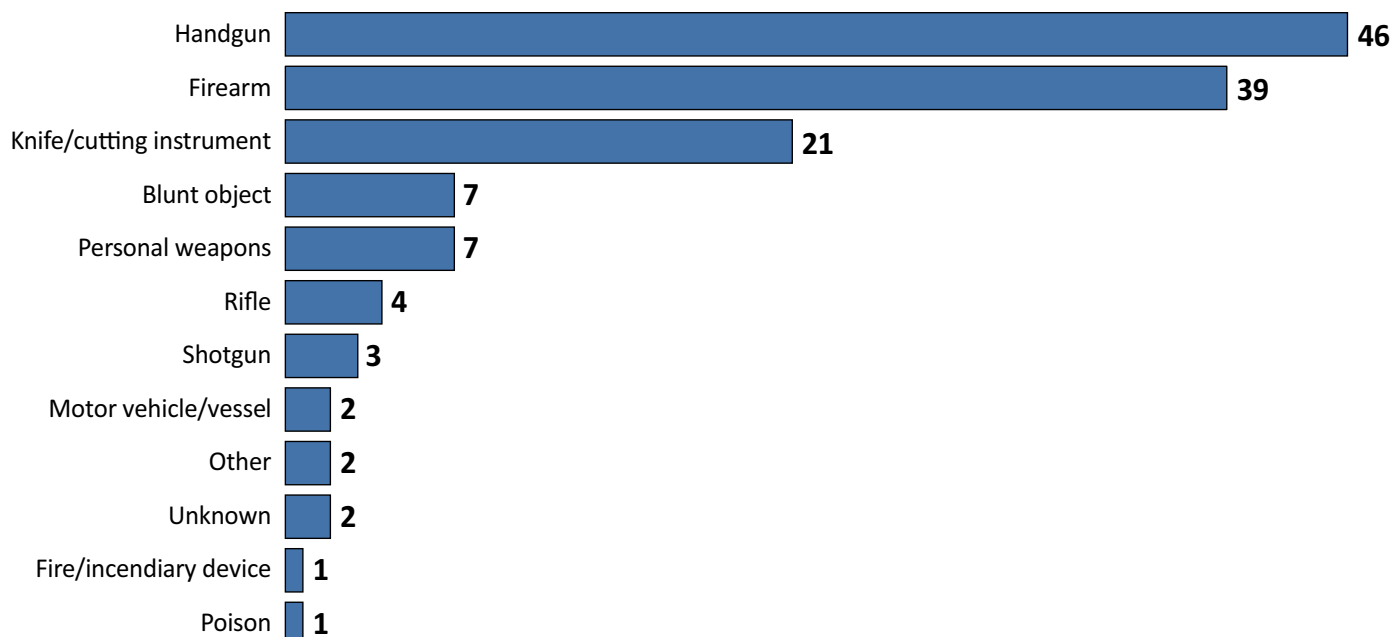
Data on homicide of an unborn victim is collected to meet Minnesota reporting requirements. It does not meet the FBI’s Uniform Crime Reporting definition of homicide. As a result, homicide of an unborn victim is reported as a separate category. There were zero homicides of an unborn in 2025.

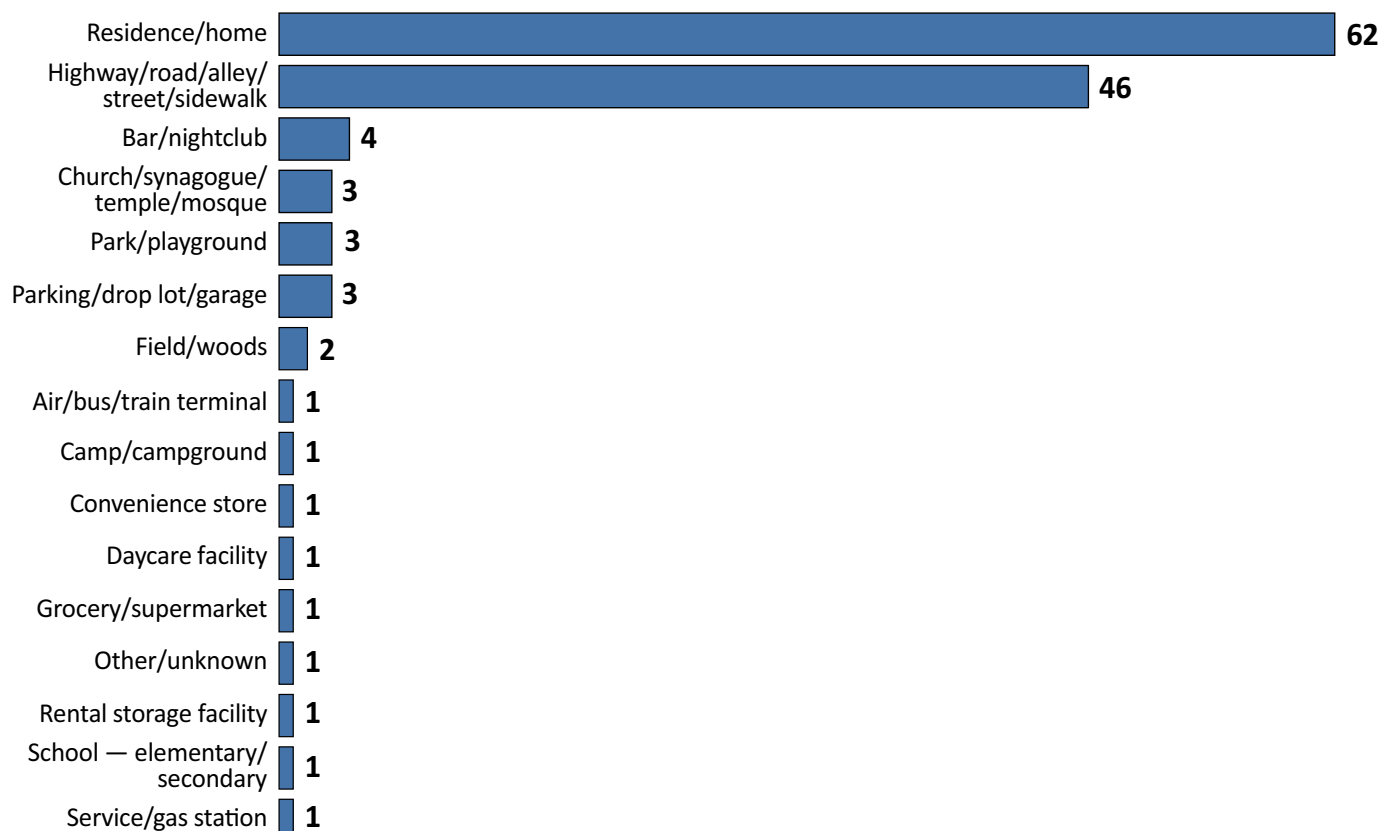

Type of weapon or force involved

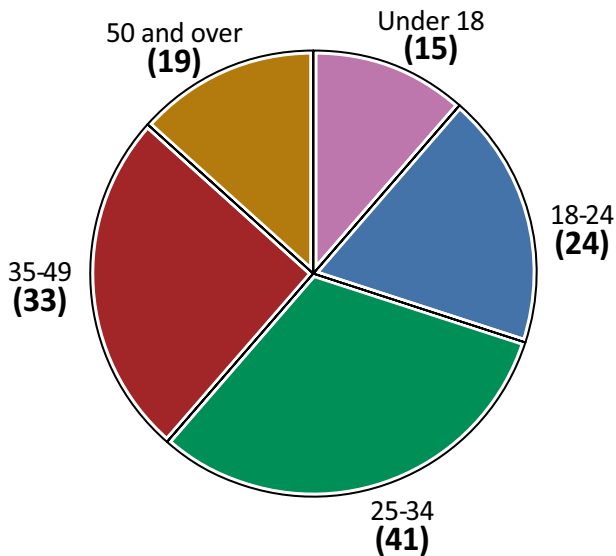

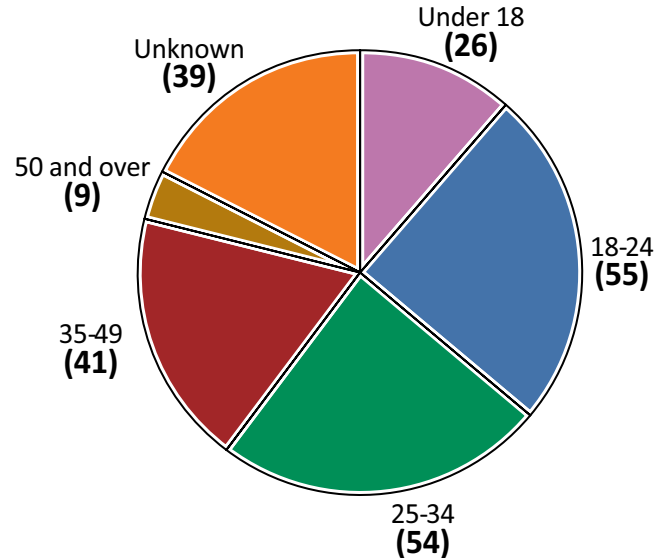

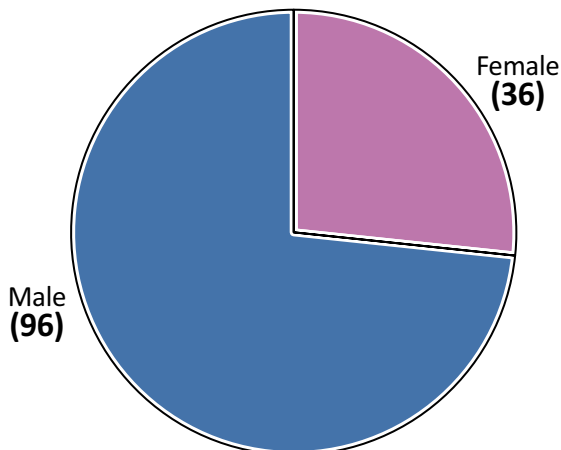
Homicide victims by age



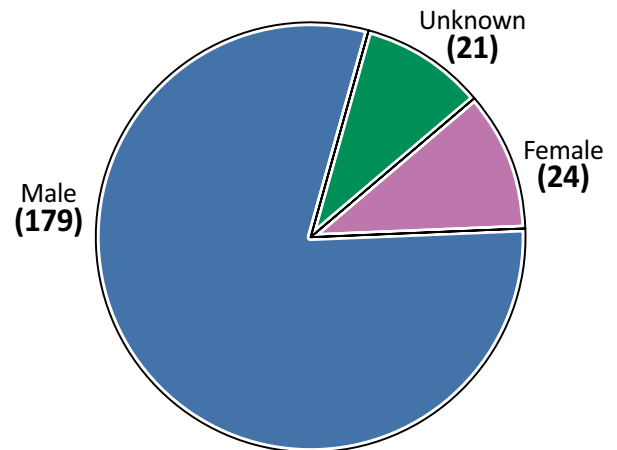
Homicide offenders by age



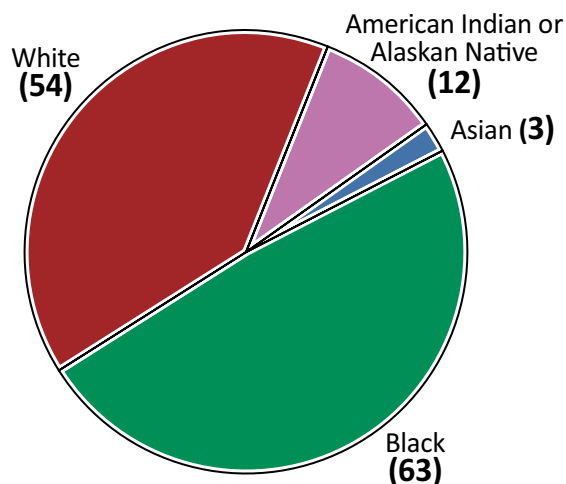
Homicide victims by sex



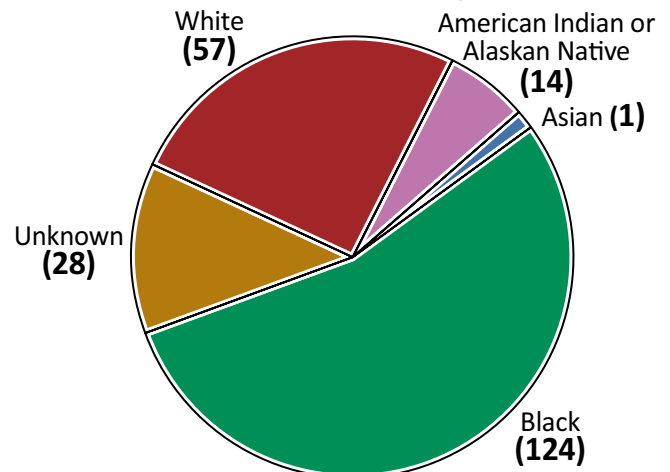
Homicide offenders by sex

Rape

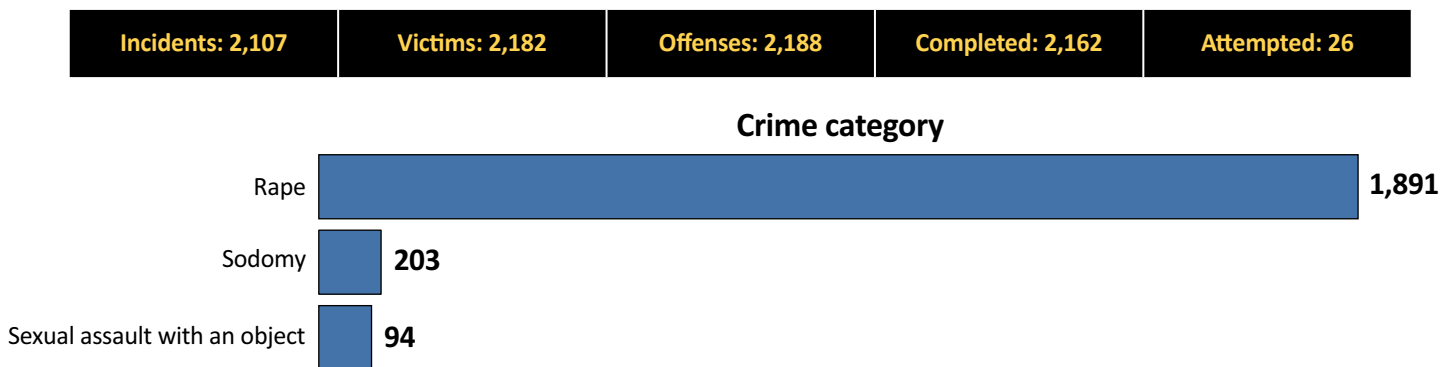
This includes any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent.

The FBI Uniform Crime Reporting definition for rape includes “the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.” For this section, it includes the following offenses:

- Rape (except incest and statutory rape) — the carnal knowledge of a person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.
- Sodomy — oral or anal sexual intercourse with another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.
- Sexual assault with an object — to use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity.

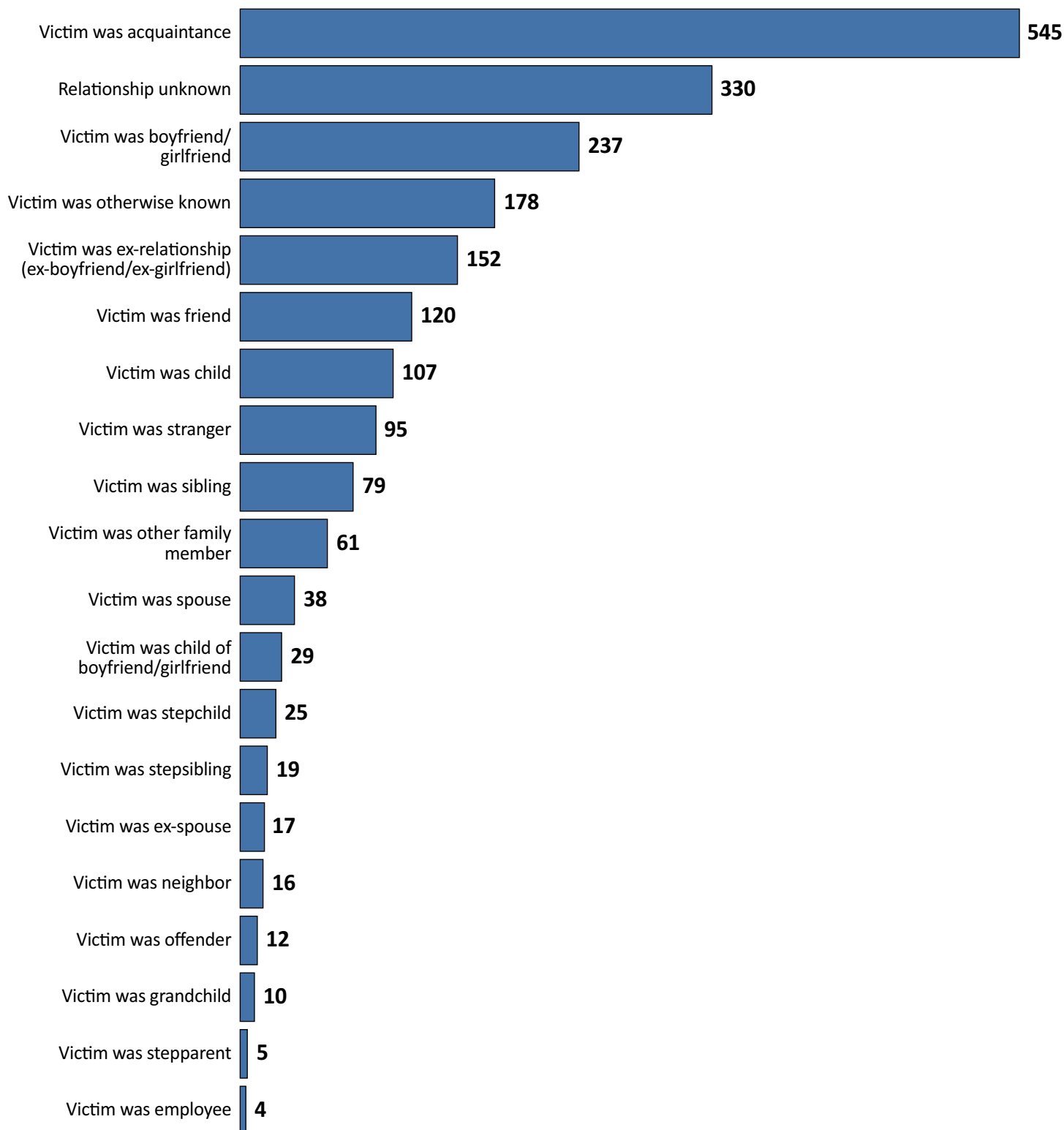
Summary rape information

In 2025, there were 2,188 offenses of rape reported, with 2,182 victims. Of the offenses reported, 2,162 were completed and 26 were attempted. In 2025, 563 rapes were cleared by arrests or exceptional means, with 36 of these arrests of a juvenile only. The crime rate for rape in 2025 was 37.5 per 100,000 population.



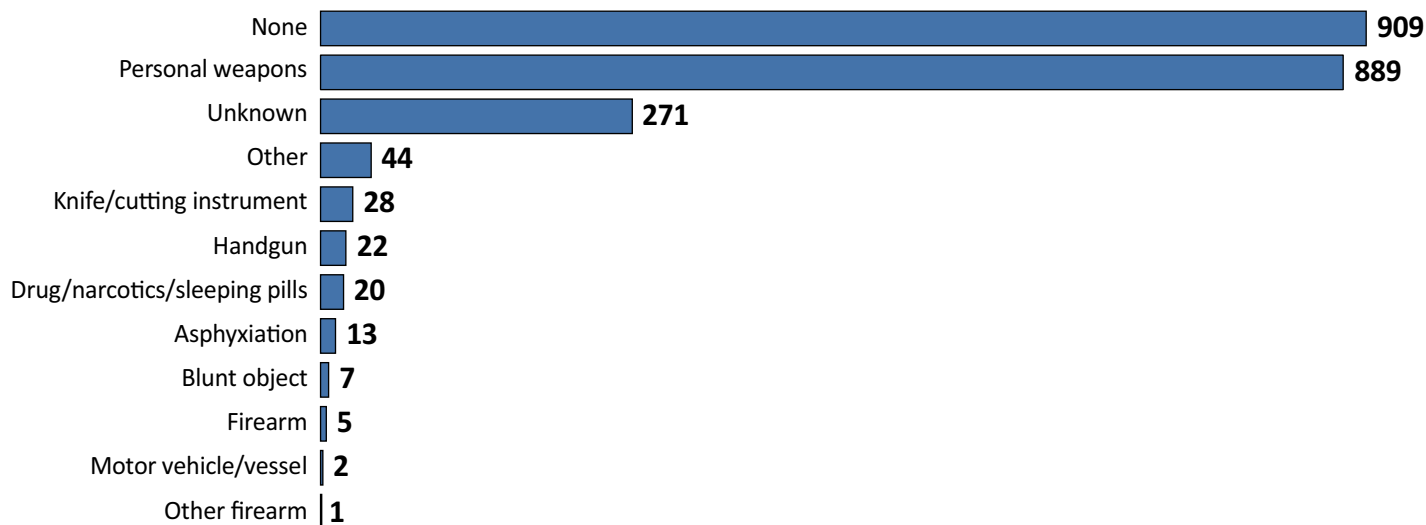
Crimes of violence – rape

Victim-offender relationship

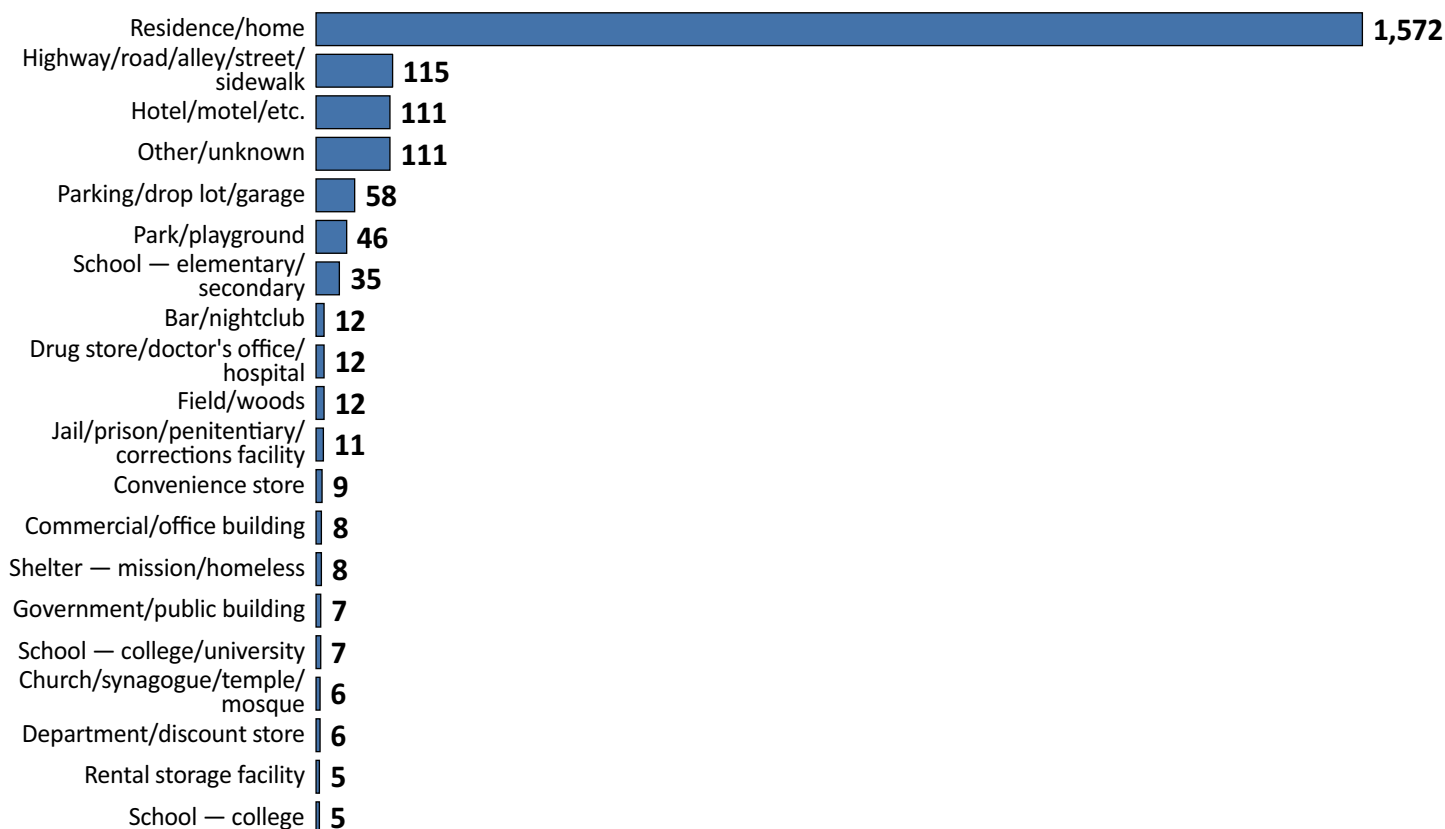

Type of weapon or force involved

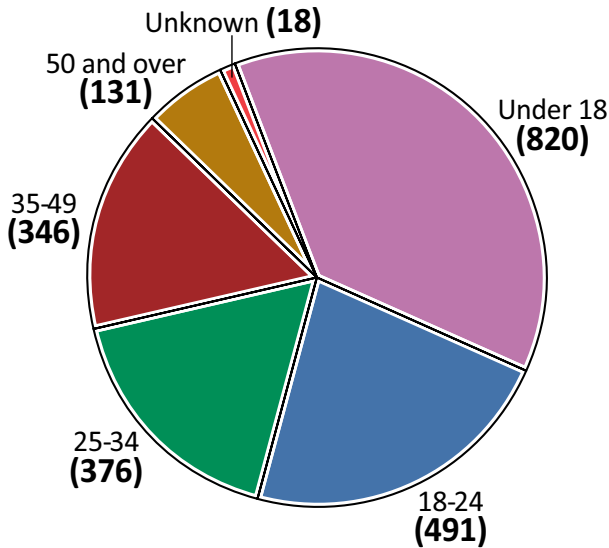

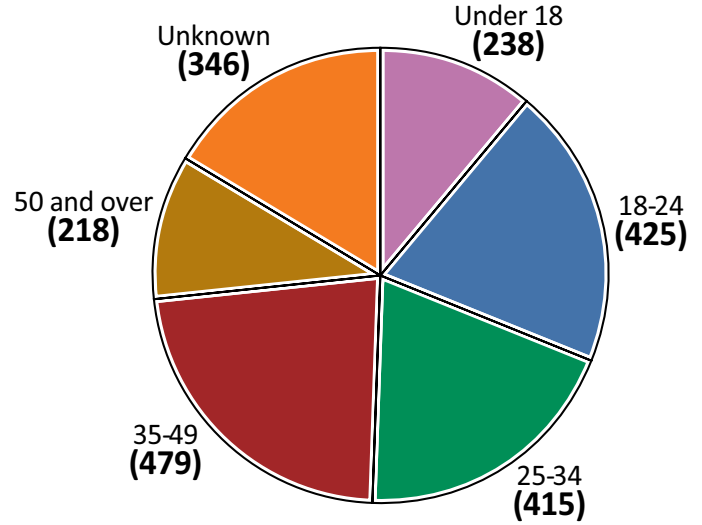

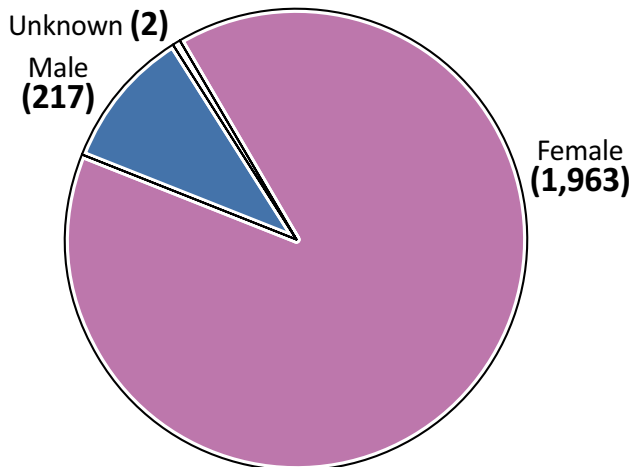
Rape victims by age



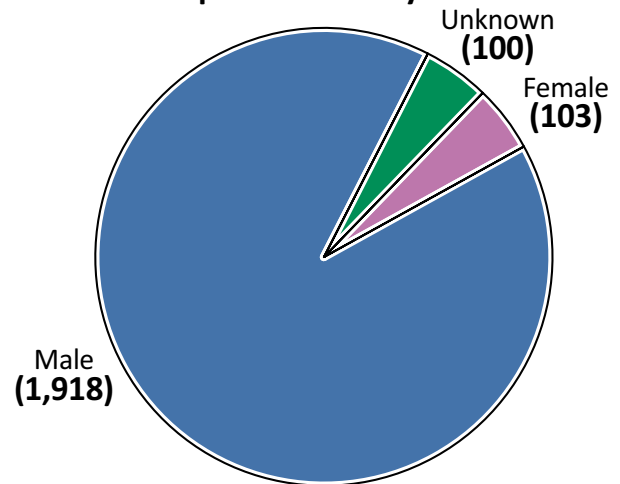
Rape offenders by age



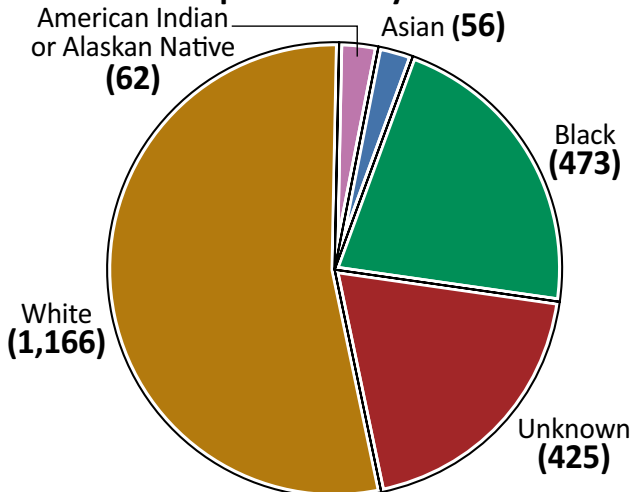
Rape victims by sex



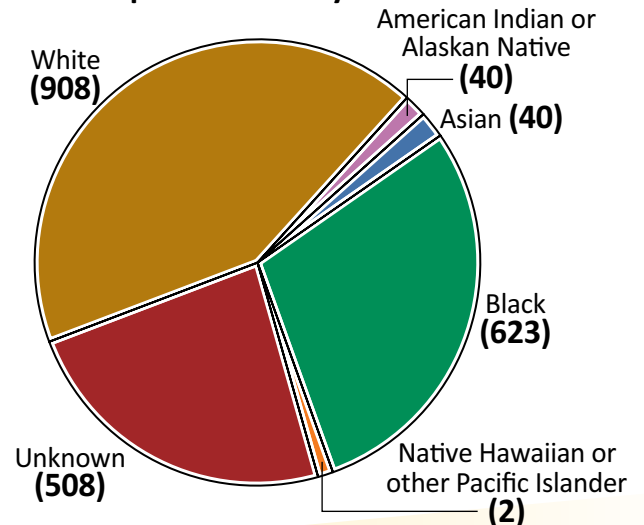
Rape offenders by sex

A robbery is the taking of anything of value from the control, custody or care of another person by force or threat of force and/or by putting the victim in fear of immediate harm.

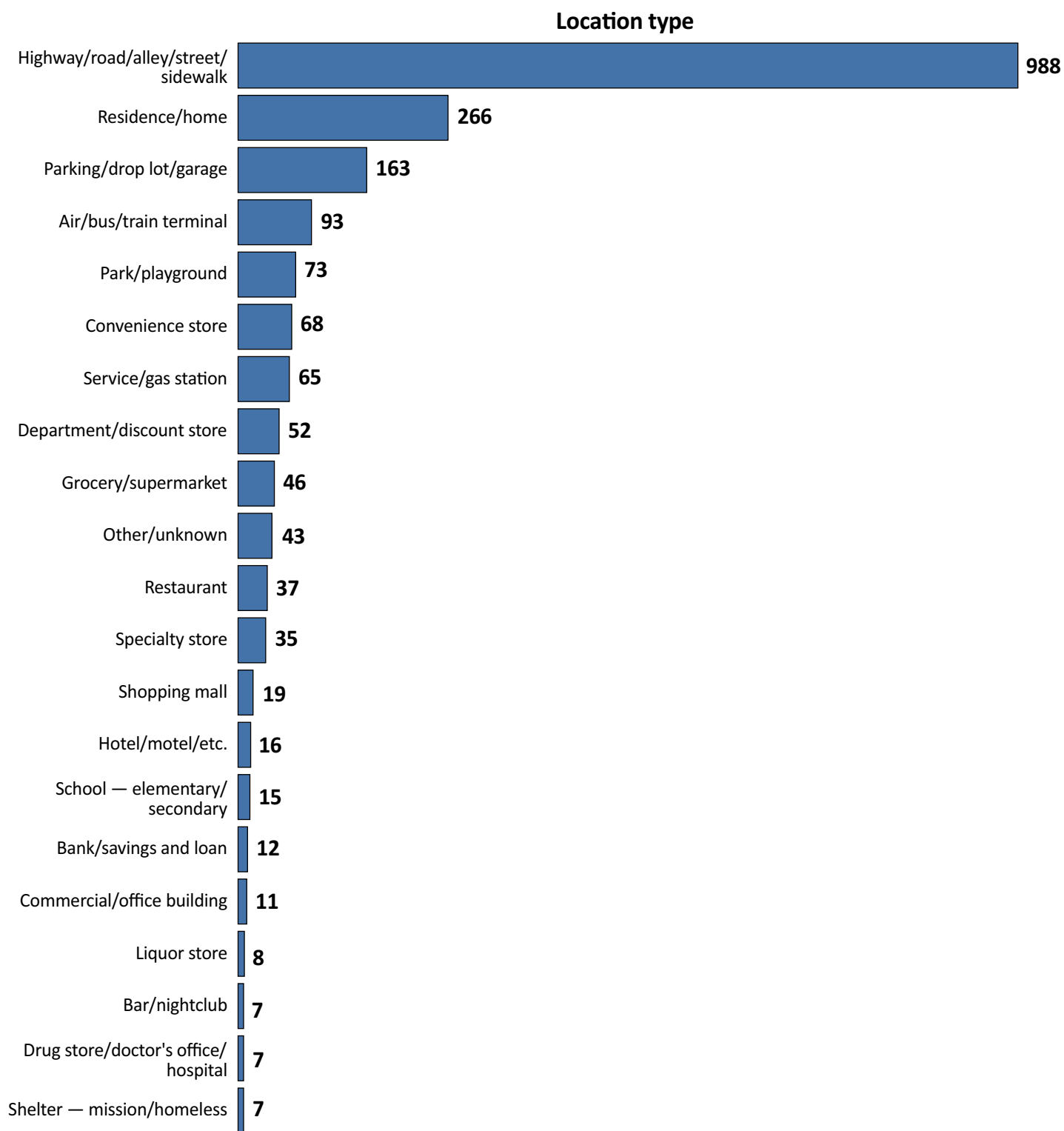
Summary robbery information

In 2025, 2,054 offenses of robbery were reported with 2,446 victims. There were 566 robberies were cleared by arrest or exceptional means with 119 of these by the arrest of a juvenile only. The crime rate for robbery in 2025 was 35.2 per 100,000 population.

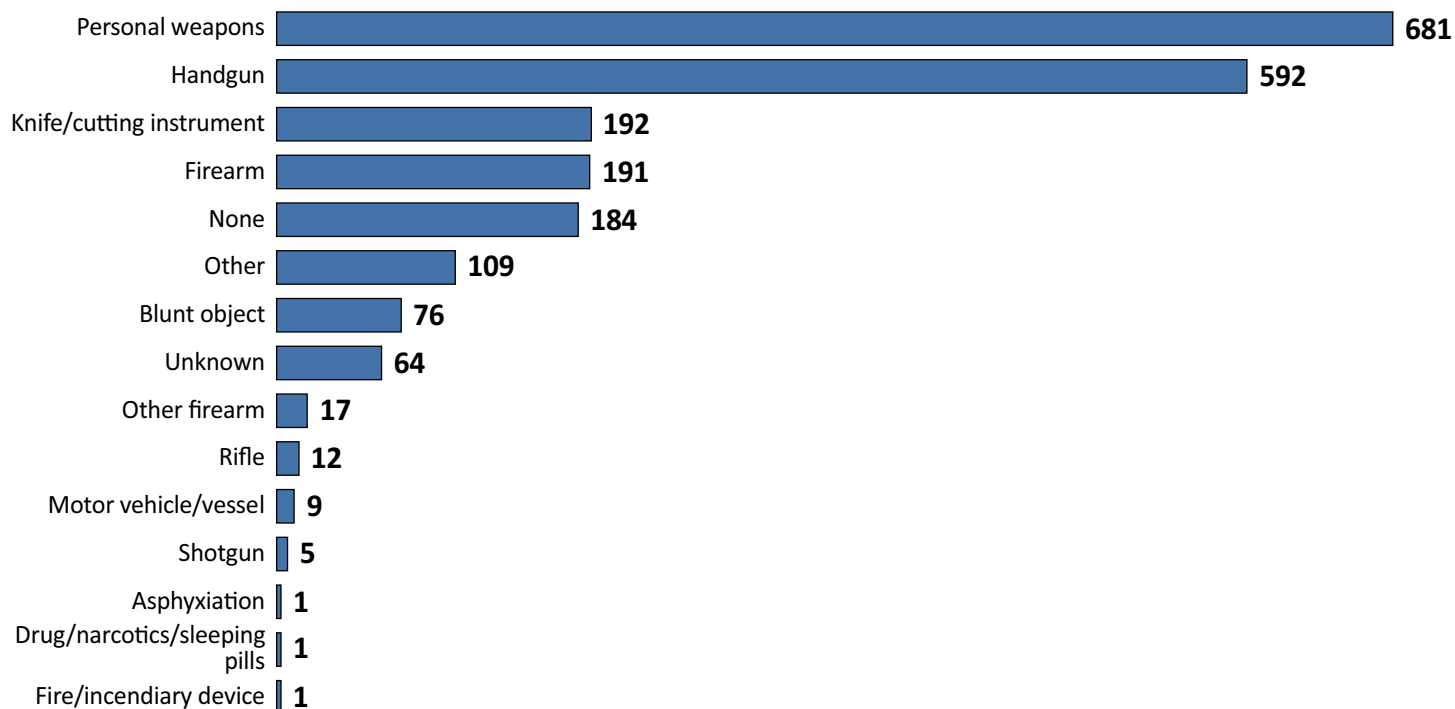

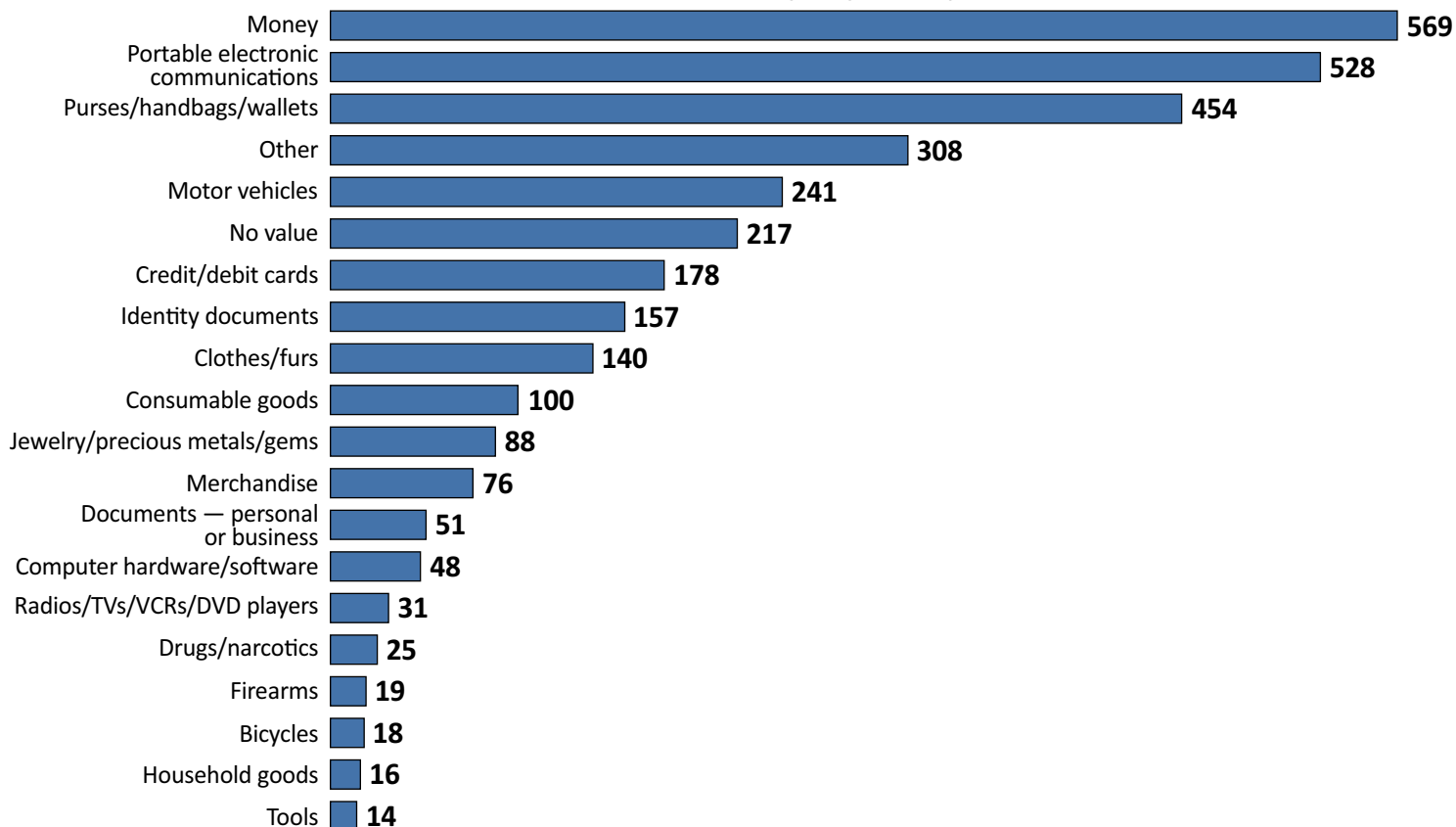


Crimes of violence – robbery

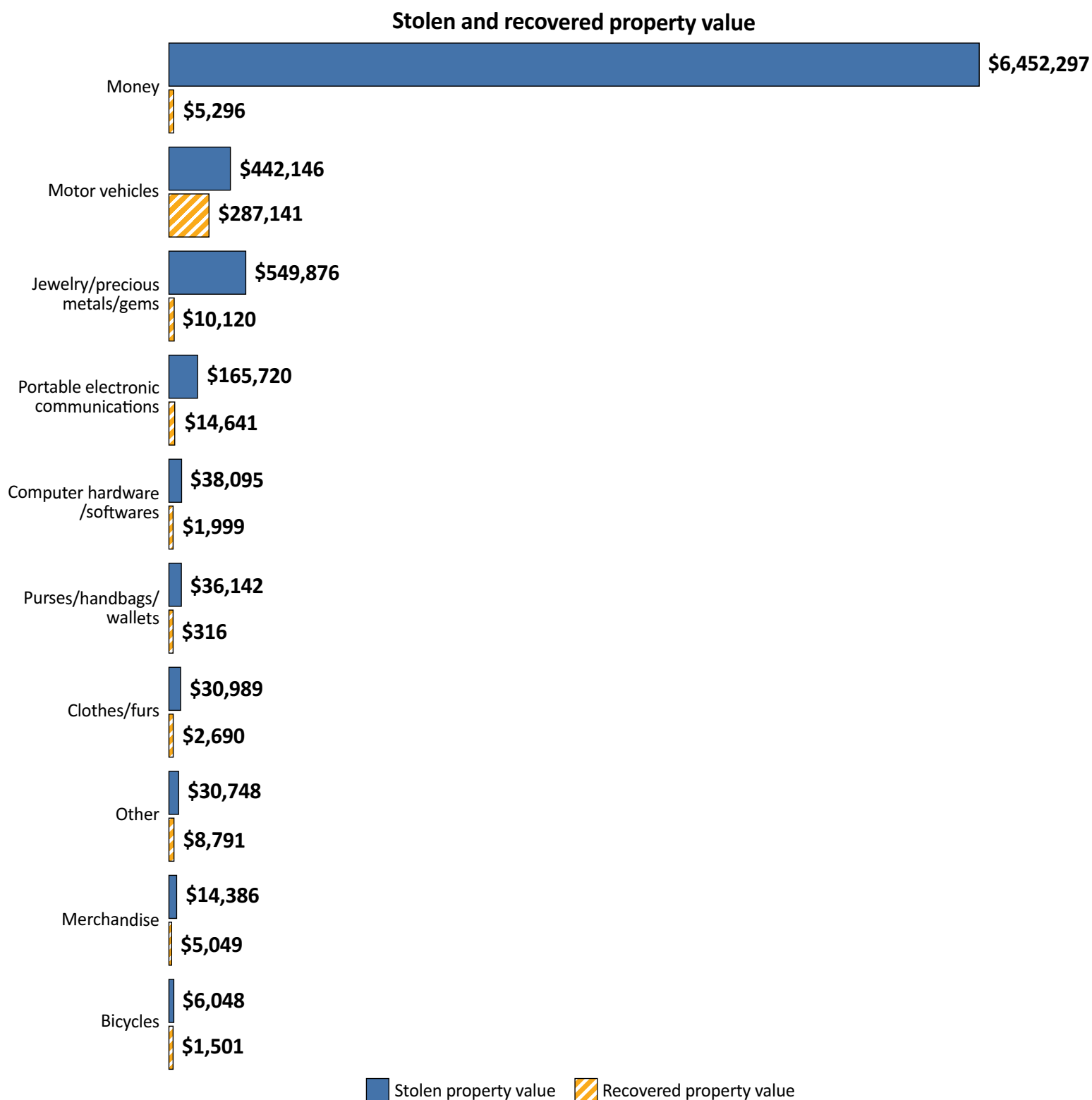
Type weapon or force involved

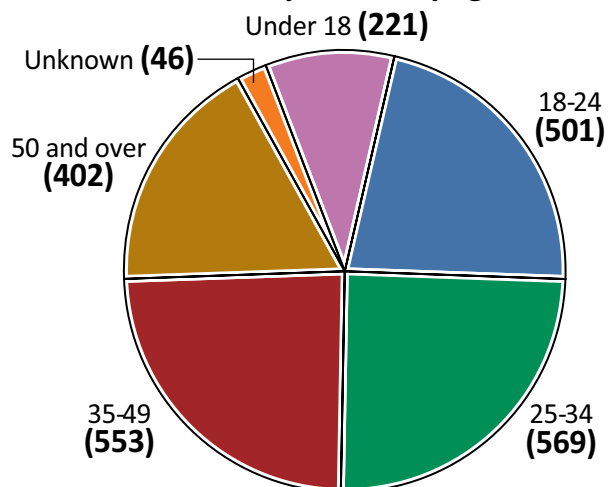

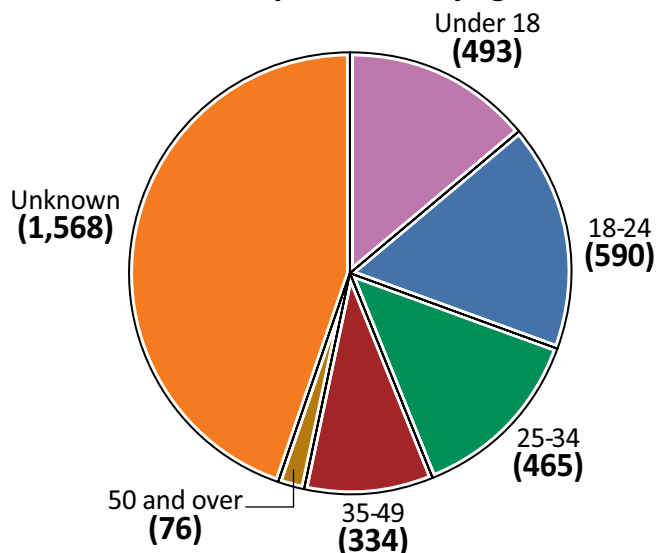

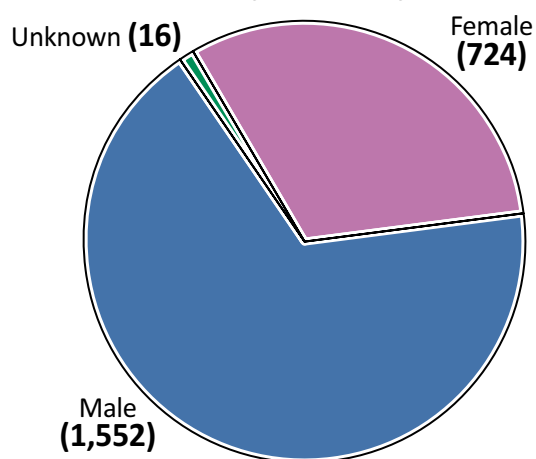
Robbery victims by age



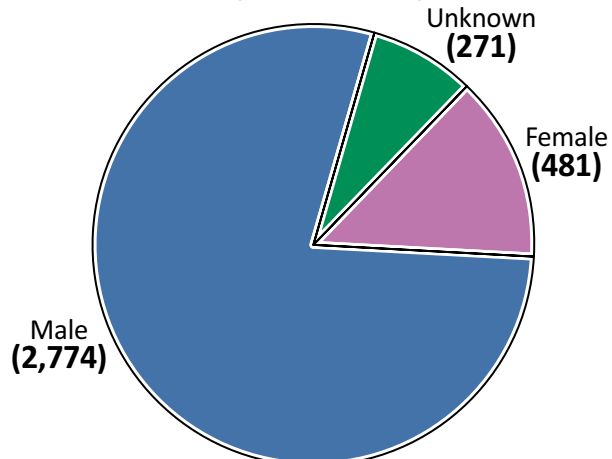
Robbery offenders by age



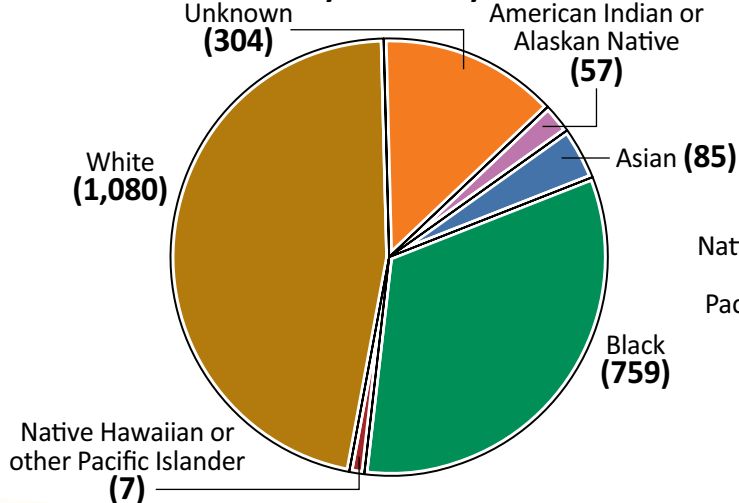
Robbery victims by sex



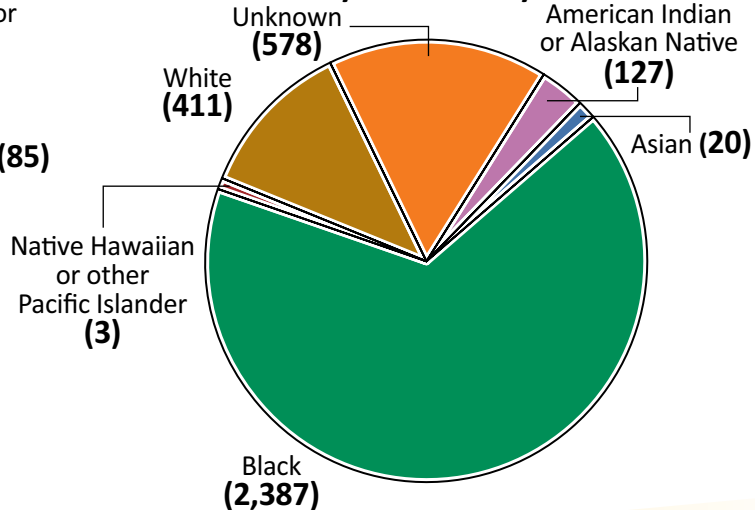
Robbery offenders by sex

Crimes of violence – carjacking

Carjacking

A carjacking is a robbery where the property stolen by force is a motor vehicle.

There were 294 carjacking incidents reported in 2025; 254 of these carjackings were completed and 40 were attempted. In 2025, 100 were cleared by arrest or exceptional means with 32 of these by the arrest of a juvenile only. The crime rate for carjacking in 2025 was 5.1 per 100,000 population.

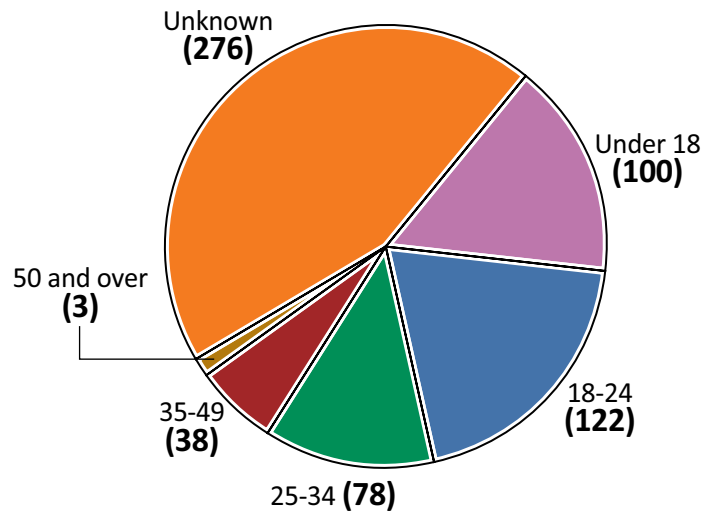

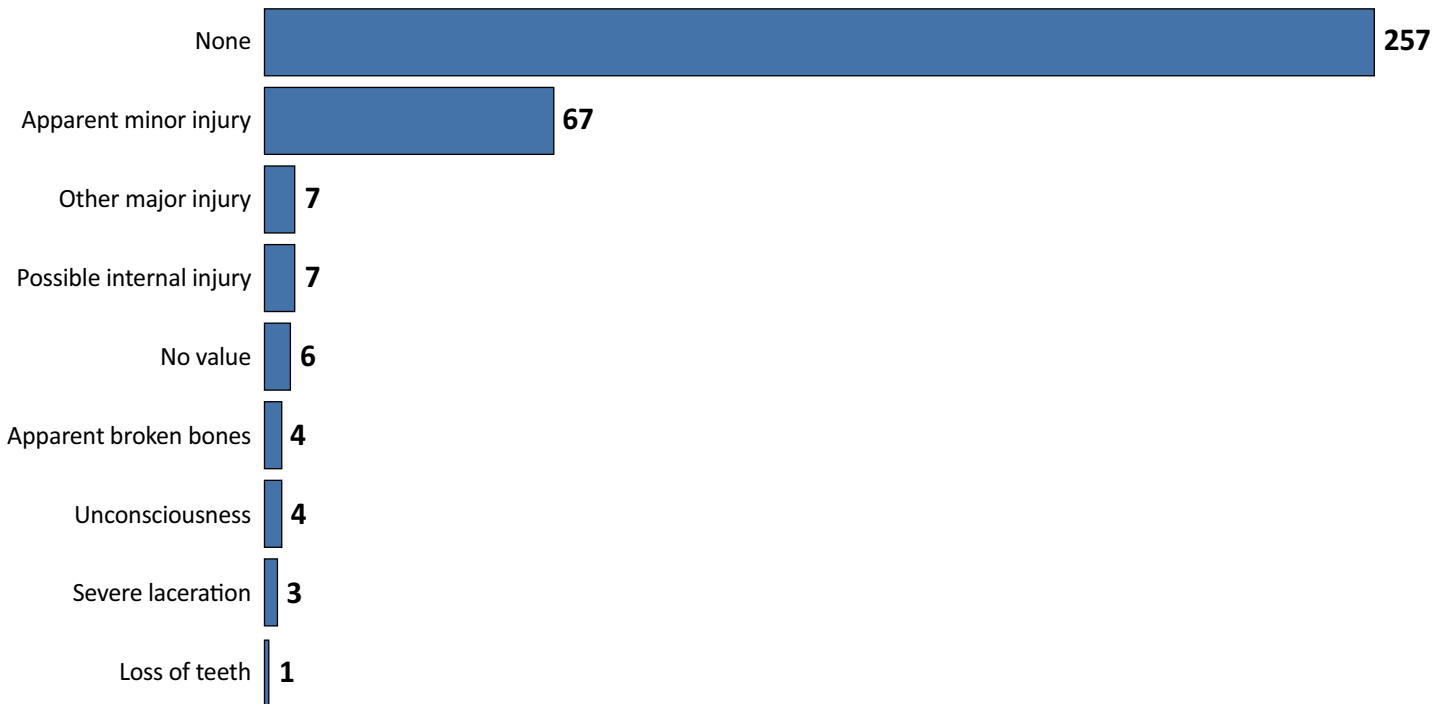

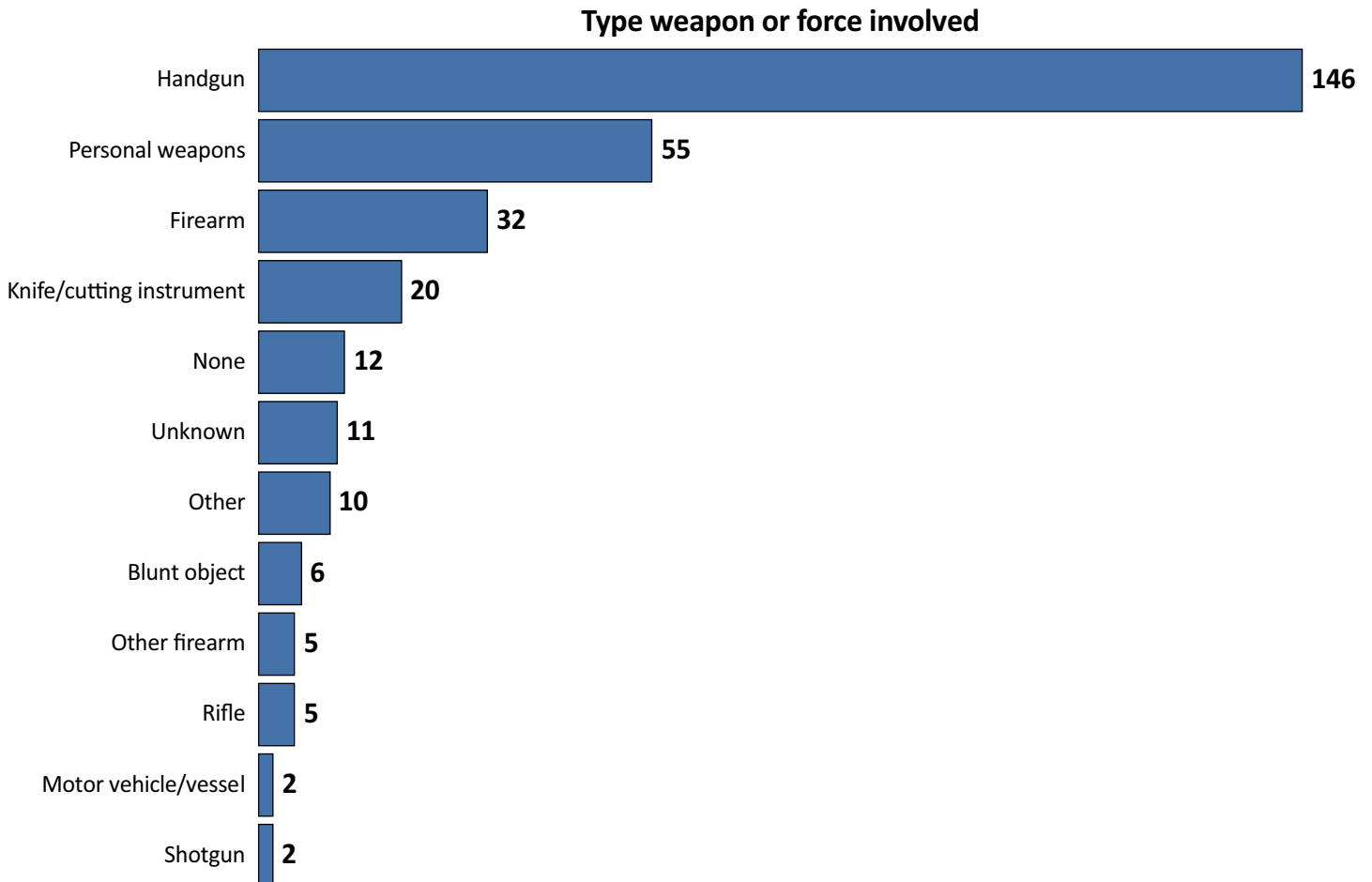
Carjacking victims injured vs. uninjured

Burglary is the unlawful entry into a building or some other structure to commit a felony or a theft. By definition, a structure has four walls, a roof and a door. The definition structure also includes any house trailer or other mobile unit permanently fixed as an office, residence or storehouse. Tents, tent trailers, motorhomes, house trailers or any other mobile unit used for recreation purposes are not structures.

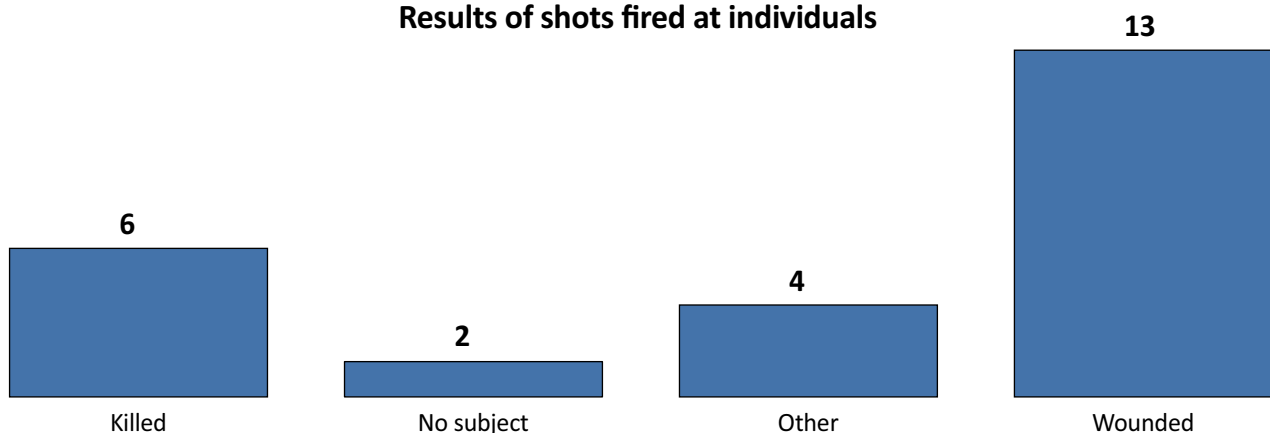

- 4 had a resulting injury level of “other,” meaning they were not injured as a result of the firearms discharge

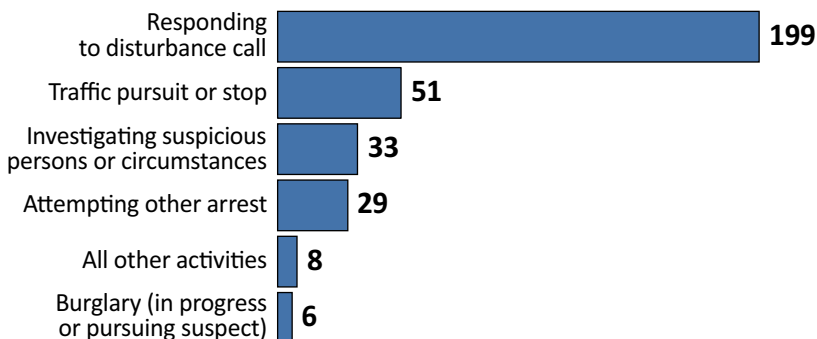

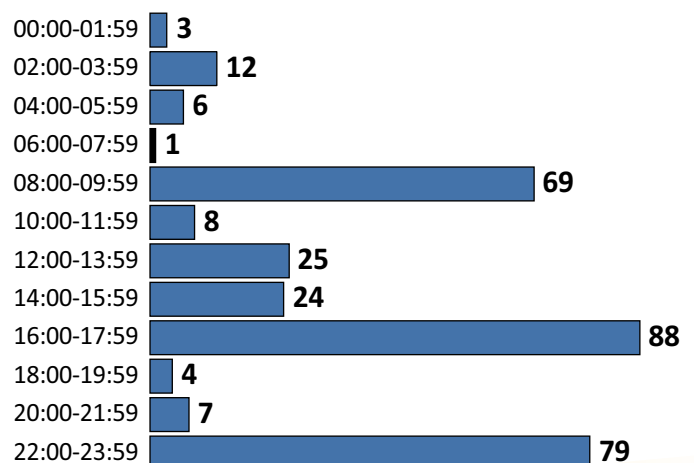
Results of shots fired at individuals

Use of force

The Minnesota Legislature in 2020 enacted Minnesota Statutes, section 626.5534, which requires Minnesota law enforcement agencies to provide information about use of force for the FBI Use-of-Force Data Collection. Agencies had already begun providing data on a voluntary basis in 2018 shortly after the FBI first established the data collection. The FBI created this data collection to inform the national conversation about officer use of force and provide an aggregate view of reported incidents and their circumstances, subjects and officers involved for better statistical analysis.

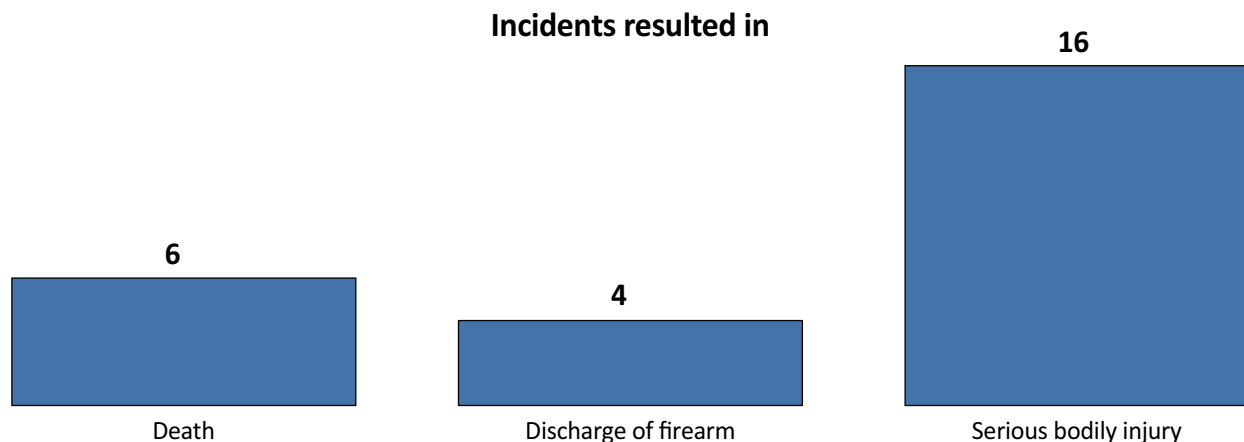
The FBI identified three types of use-of-force incidents about which agencies must report:

- When a fatality occurs to a person in connection to use of force by a law enforcement officer.
- When there is serious bodily injury to a person in connection to use of force by a law enforcement officer.
- In the absence of either death or serious bodily injury, when a firearm is discharged by a law enforcement officer at or in a direction of a person.

The FBI requirements allow agencies to choose Pending or Unknown values for data elements when data is not known or cannot be released due to an outside agency's active investigation. Agencies are expected to amend the reports once the data becomes available. In the figures below, "Subject" indicates the individual the force was applied to.

Summary use-of-force information

In 2025, there were 26 use-of-force incidents. six of these incidents involved the death of a subject, 16 of these incidents involved the serious bodily injury of a subject, and 4 of these incidents did not involve the death or serious bodily injury of the subject.

This data must be reported to the commissioner of public safety within 30 days of the incident.

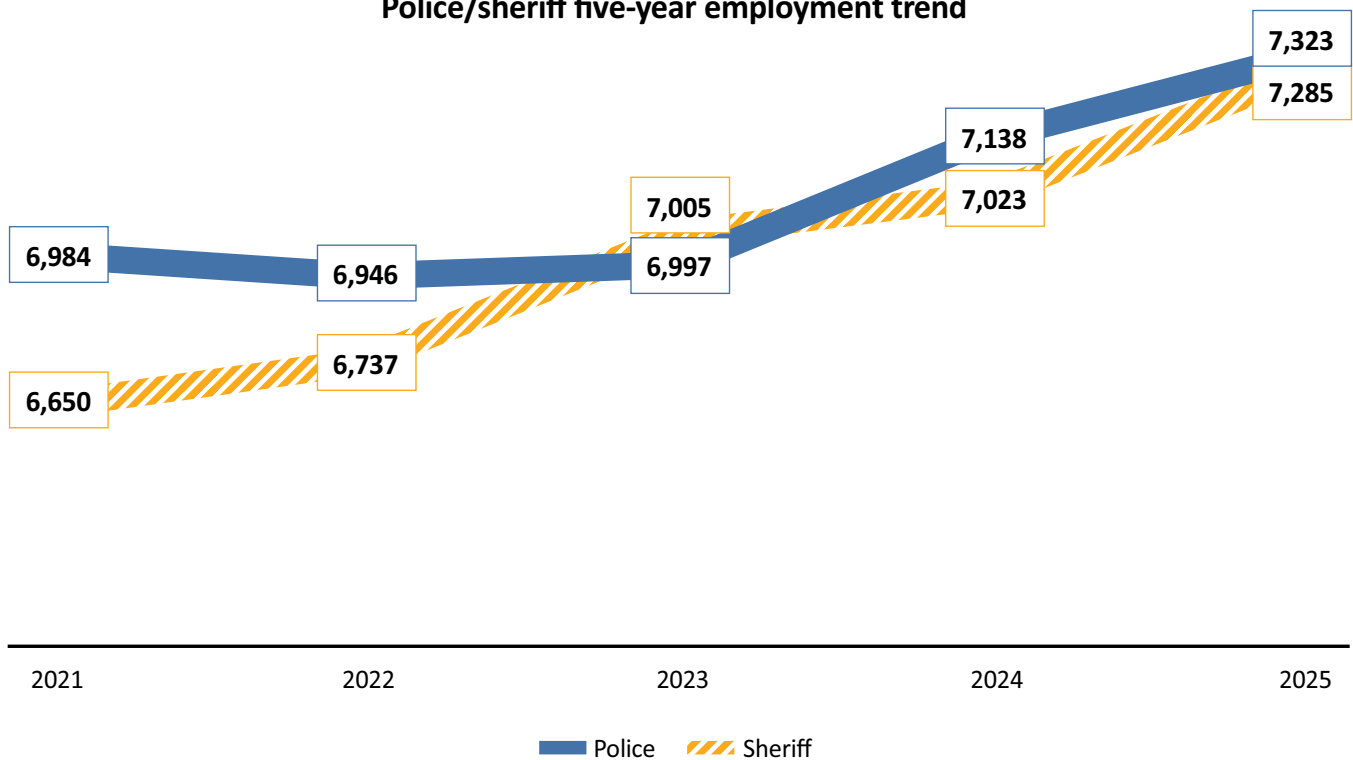
Minnesota state law enforcement agencies reported a total of 14,608 sworn and civilian employees for 2025. Of those, 9,041 were sworn personnel and 5,567 were civilian employees.

The average number of full-time law enforcement personnel in 2025 (including sworn and civilian) amounted to 2.5 employees per 1,000 residents. The average number of sworn personnel (excluding civilian) amounted to 1.6 full-time sworn personnel per 1,000 residents.

Staffing levels in 2025 and changes from the previous year were as follows:

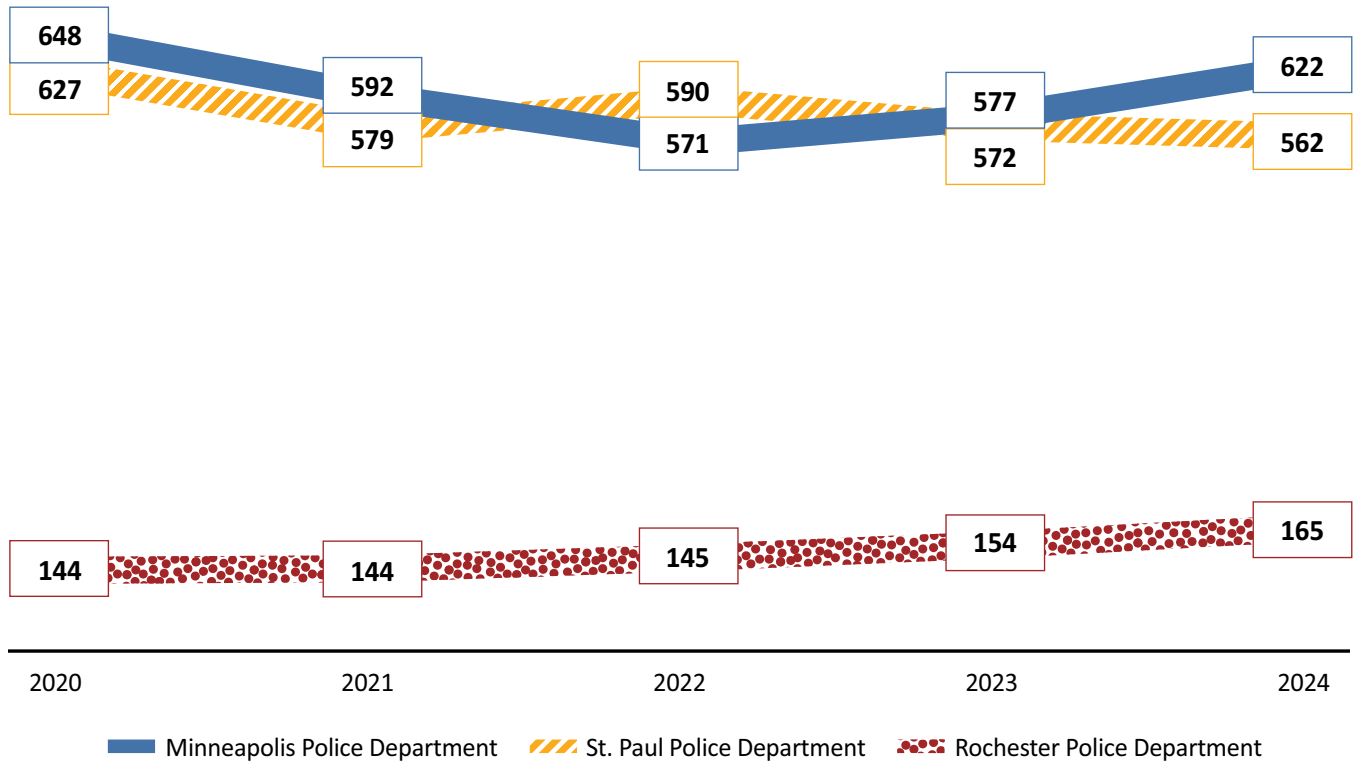
- Sheriff's departments reported a total of 7,285 employees in 2025, which was an increase of 3.7 percent from the 2024 total of 7,023. Of the sworn personnel, 2,767 are male and 336 are female. Of civilian personnel, 2,177 are male and 2,005 are female.
- Police departments reported a total of 7,323 employees in 2025, which was an increase of 2.6 percent from the 2024 total of 7,138. Of the sworn personnel, 5,057 are male and 881 are female. Of civilian personnel, 438 are male and 947 are female.
